**Asphalt Release Agent  
Submittal for Testing and Approval**

Effective: July 1, 2007  
Revised: November 13, 2009

**A. Scope**

Before an asphalt release agent is used for a Department project, it will be tested and approved. The following guidelines are provided to clarify the submittal requirements and expedite the testing process for asphalt release agents. Test procedure:

**B. Procedure**

When submitting an asphalt release agent to the Department, the following shall be included:

- The specific product brand name,
- Material Safety Data Sheet,
- Technical Data Sheet,
- Contact person's name, title, address, email address, and phone number

The manufacturer shall submit a 1 quart (1 liter) undiluted sample of each product intended for use on Department projects.

The sample and submittal information shall be sent to:

Any sample provided without the required information listed will not be tested. Any changes by the manufacturer in the formulation outside the manufacturer's original parameters will necessitate a new sample submittal.

You will be notified by letter when the sample testing is complete. If you have any questions regarding the testing and approval process, contact Joe Rechner at 217-785-7217.

The Department shall be notified of any change to contact information. Failure to do so may result in removal of product from the approved list.

**C. Re-Approval**

Re-approval of asphalt release agents is required every 5 years. Upon time of re-approval, a letter will be sent to the manufacturer.
