**A. Scope**

The following guidelines are provided to clarify the submittal requirements and expedite the process for supplying precast concrete products to Department projects.

**B. Procedure**

When requesting to be a certified precast concrete producer with the Department, a Quality Control Plan shall be submitted for evaluation and approval. The Department will also inspect the producer's plant/laboratory, and obtain samples of component materials for testing.
